1. **Council Approval of Council Work Session and Regular Meeting Minutes from February 19, 2024-**

It was moved to approve the Council Work Session and Regular Meeting minutes from February 19, 2024.

PUBLIC COMMENTS: (All Speakers will have 3 Minutes)

There were four (4) public comments:

John Randle: noted that PD had been called on him for popping fireworks. He noted he had a permit and spoke of the times in which he was allowed to do so. He noted that taxpayers' dollars were being wasted for police to come out for people popping fireworks, but not come out for gunshots and drugs. He thanked Chief Criss and noted he does a great job.

Samuel Ibenez – noted that he had noticed some differences in the public and wanted to thank the officers.

Laverne Mitchell – noted that there are fireworks popping day and night and it is disrupting their peace. She noted here and the other residents would like something done because it has been a continuous complaint.

LaWanda Folami – wanted to invite them over to the leisure center, noting all this week the kids are playing basketball in the center. She noted she would like to see some of them there cheering the children on. She noted she saw they discussed partnering with the High School. She noted she does not have a problem with the partnership, but with every one of them not knowing what is going on. She noted they want to partner with children overall, but what about the immediate ones in Forest Park? She wanted to know what happened to Arbor Day for the seniors and would like them to bring it back.

CITY MANAGER'S REPORT

City Manager Clark- noted they are working on uniformity on what the park signage would look like. He noted they would try something to the Gateway sign, since the council and mayor liked it so much. He is looking for feedback from the governing body on which design they like and will proceed to send to procurement for pricing.

Mayor Butler- noted there are still some old Forest Park signs that are out and wondered if they would be replacing them.

City Manager Clark- noted they can now that there is some consistency.

Councilmember James- asked if there was a way to get some history behind the name of the sign posted on the back of it.

City Manager Clark- noted he did not know about putting it on the sign but they could do a display to give the history.

Councilmember Akins-Wells- wants to look into her sign glowing in the dark.

Mayor Butler- noted she could use her Capital Outlay money for it.

City Manager Clark -noted they may not glow in the dark, but their will be uplighting. He noted for the Home Program there are 122 pre-qualified and verified residency. He noted the respective number for each Ward is : Ward 1- 22 verified, Ward 2- 28 verified, Ward 3 -22 Verified, Ward 4-32 verified, and Ward 5-18 verified. He noted Pauline and the Council Aides have done an amazing job with this. He noted they are about to go through the 2nd phase of sending out denial letters. He noted they will reopen the portal once they get through funding the Legacy Residents. He noted if they do not request the full 10 thousand dollars there will be funding left. He introduced the new employee Nina Robertson of the Finance Department. He announced the appointment of Rochelle Dennis as the Interim person in charge of the Economic Development Department.

Councilmember Akins-Wells- asked if they would provide a least of contractors for the home repair.

City Manager Clark- stated they would be able to choose their own. He noted there are 22 contractors already to assist with the program if needed. He noted instead of doing 3 rounds with the funding to contractors they will only be doing 2 rounds. To make sure they are not preying on the legacy residents they will receive a portion up front and the remainder once the job is completed.

PRESENTATIONS:

2. Introduction to the New Deputy Fire Chief of Operations–Geoff May-Forest Park Fire & EMS

The Forest Park Fire and Emergency Services just appointed Geoff May as Deputy Fire Chief of Operations, effective March 4, 2024.

A Short presentation will be given by Chief Latosha Clemons.

Chief Clemons noted he has been serving the city for 37 years. She noted he is an excellent commander and would be over the 3 Battalion Chiefs A, B and C, and will manage all the operations.

Deputy Chief Geoff May- noted he is humbled and privileged. He noted he has been on shift for the entire 37 years. He hopes to make the department proud and take care of the men and women under his charge.

City Manager Clark noted instead of 10 percent, 10 mils.

Councilmember James noted they have a list of roads that need to be repaired and feel they need to find a better way to get the information out on the roads that are going to be repaired because she is getting a lot of calls.

Councilmember Antione – shouted his Ward and wanted it to be known they are in good shape. He gave a shoutout to the new employees and thanked them.

Councilmember Gutierrez – thanked everyone for coming and welcomed the new employees. He congratulated the new Deputy Chief of Fire and thanked him for his commitment. He noted he believes in everyone's freedom but wants to make sure the curfew for fireworks is being respected. He thanked everyone for coming out. 150

Councilmember Akins-Wells- welcomed the new employees, congratulated Chief May, and thanked him for his dedication to the City of Forest Park. She noted she does not think people should have to tolerate certain things and would like to see what can be done about it. She noted she thinks people should be careful about whom they choose to put in office because they do not always have good intentions.

Councilmember Mears – congratulated the new Deputy Chief and noted he has known him a long time and he does a fine job. He recognized Mr. Finch and thanked everyone for coming out.

Mayor Butler- thanked everyone for coming. She noted the City Attorney is working on providing an Ordinance to strictly regulate the use of fireworks. She noted that rules on the state level are for special days like the 4th of July, New Year's, etc. She noted it takes time to put these things together because of legality, but they hear what is being said.
